

**QUAKER CAP'N CRUNCH Spin You Could Win
INSTANT-WIN GAME
OFFICIAL RULES**

NO PURCHASE NECESSARY TO PLAY OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. GAME PERIOD. The Quaker Cap'n Crunch Spin You Could Win Instant-Win Game (the "Game") begins at 12:00 p.m. Eastern Time ("ET") on June 18, 2018 and ends at 11:59:59 p.m. ET on November 30, 2018 ("Game Period").

2. HOW TO PLAY THE INSTANT-WIN GAME. To participate in the Game, an eligible participant must obtain a game code ("Code"). Codes may be obtained using the following three (3) methods:
 - a) Make a purchase: During the Game Period, an eligible participant may purchase specially marked Cap'n Crunch cereal boxes (including Cap'n Crunch 20oz and Cap'n Crunch Crunchberries 18.7oz) at participating Dollar General® locations while supplies last. One (1) Code will be printed inside the specially marked packaging. Quantities of specially marked Cap'n Crunch cereal boxes for sale at participating Dollar General® locations are limited and subject to availability.
 - b) Without a Purchase (Mail-In Code Request): To obtain a Code without making a purchase, via mail-in request, an eligible participant must legibly hand write his/her full name (no initials), complete street address (no P.O. boxes), age, and valid email address on a 3½" x 5" postage prepaid, properly stamped postcard and mail it to: Quaker Cap'n Crunch Spin You Could Win Instant-Win Game Code Request, P.O. Requests sent in an envelope will not be accepted. **Mail-in requests must be received by November 20, 2018.** Administrator will send one (1) Code by email to the email address provided on the request. Mail-in requests will not be returned, and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed. Limit one Code per request.
 - c) Without a Purchase (Online Code Request): To obtain a Code without making a purchase, via online request, **between 12:00 a.m. ET on November 21, 2018 and 11:59:59 p.m. ET on November 30, 2018** an eligible participant may visit www.CrunchSpintoWin.com/amoe and follow the on-screen instructions to obtain one (1) Code via email.

To play the Game, after obtaining a valid Code and during the Game Period, an eligible participant must visit www.DGRewards.com/PepsiCo and click on "Crunch Spin You Could Win" then enter his/her date of birth followed by his/her email address. The participant must then follow the instructions to register by providing all required information, including, but not limited to, first and last name (no initials), street address (no P.O. boxes), city, state, and zip code and agree that he/she has read and agrees to be bound by these Official Rules. The participant must then enter a valid Code and follow the instructions to earn one Game play ("Play"). For purposes of this Game, a participant will not be permitted to change his/her email address or street address after registering.

If a participant receives a prize-winning message upon submitting a Play he/she will be notified on-screen that he/she is a potential Game prize winner, subject to verification. Game prize winners will be determined by a random, time-based seeding process, administered by an independent third-party administrator ("Administrator"), whose decisions are final and binding in all matters relating to this Game.
